- Zero Bases Budgeting Exercise
 - i. Services
 - Night by Night costs \$220k to run year round
 - Collect some cash donations and also in-kind food donations each year
 - Number of participants in shelter is growing and that means costs and expenses are growing
 - Wages of staff are up as are more people using shelter
 - Grants issued from new administration are stating no more housing to DEI or illegal immigrants; will need to increase verification services to comply with new policies
 - Highest priorities are Year-Round NbN, Housing Stability, and Family Shelter

- Data Committee MD data collaborative did data scorecard help to track people flowing into and out of housing program
 - i. Have a follow up meeting with consultant in 4-6 weeks
 - ii. System Performance Measures delayed; due April 12
 - iii. Working on a new draft with DHCD on Data Sharing Warehouse mechanism to protect a person's data who doesn't want information shared
 - iv. Reaching out to WellSky for a data dictionary
 - v. Emma Diblasi new HMIS specialist starts Thursday
- Equal Access is still the law and must be followed
- HUD anticipated 50% cut in staff
- Homelessness staff cut 84%

- COC awards have been removed from HUD website
- Need to start messaging with landlords and developing contingency plans
- FY26 HSP Grant should be out today
- Anticipate Housing First will go away
- HUD not subject to the restraining order
- YHDP application information is gone from website
- FY26 for the federal government starts October 1st
