- **II. Greetings and Introductions:** Christine Kuntz, Chair of the Local Management Board, welcomed the group and all participants were introduced.
- III. Minutes The May 21, 2019 meeting minutes were approved after adding Marie Liddick (LBHA) to the members in attendance.

IV. Meeting

A. GOCCP/GOC Updates

- Glenn Fueston, Executive Director for Governor's Office for Crime Control & Prevention
 - i. Maryland Association of Local Management Boards meets with Glenn (and or his staff) monthly
- Jessica Wheeler, new Deputy Director for Governor's Office for Children
- Still have base funding for FY21
 - i. GOCCP not in agreement with how Interagency Fund money was distributed
 - ii. After FY21, jurisdictions may compete against one another for future funds
- Discussion about removing strategic goals from LMB data collection
- Discussion about changing GOCCP's name

B. LMB History/Current Funding and Strategies

- As of 2020, LMBs have been present in Maryland for 30 years
- LMBs are in statute (COMAR) to exist; however, there is no funding mandated for LMBs
- Dr. Pam Brown (Anne Arundel LMB) head of the Maryland Association of LMBs
- "Local power, collective voice" is LMBs' motto
- Carroll County LMB is a quasi-county agency
- Currently a work group of Maryland LMB members is revising the indicators and results for LMB data collection
 - As such, indicators may shift; expect work group will complete revision by January

C. By-Laws and Membership

- By-Laws should have been updated in 2018; currently using the By-Laws from 2015
 - Looking to approve changes to By-Laws at next CCLMB meeting in November
- Changes to Membership:
 - Need to appoint a Vice Chair of the CCLMB
 - Need to establish an Executive Committee
 - Should consist of the Chair, Vice Chair, LMB staff, and mandated members
 - Hoping to add members to CCLMB from the following groups:
 - Business members
 - Civic members
 - Law enforcement officials
 - Hospital staff members
 - Individuals need not be associated with child-serving agency to be on CCLMB
 - Considering changing CCLMB membership term from three 3-year terms to two 2year terms
 - Suggestion to keep terms at 3-year intervals as it may take that long to understand what exactly LMBs do
 - Mandated LMB members are LBHA, CCHD, CCPS, DSS, and Citizen Services;
 these members are excluded from the term limits
- Expecting to continue having five CCLMB meetings per year

D. Local Care Team FY 19 Re-cap

- Local Care Team has been in operation in Carroll County since 2011
- Corey showed the Local Care Team Scorecard data to the group
