
Comprehensive Rezoning

The Department of Planning continues to make progress with the County's Comprehensive Rezoning initiative. This effort involves reviewing and updating Chapter 158, the Zoning Code, to ensure that the code is more modern, userfriendly, and aligns with the community's vision for the future. The initial phase of Zoning Code modifications has been to the Commercial. Industrial and Employment Campus Zoning Districts. Following a county-wide mailing to

over 49,000 households, work sessions held with the Board of County Commissioners (BCC) and two public information sessions earlier this year, the BCC has once again begun deliberating on the specific Code changes to the commercial and industrial zoning districts. The interagency Concept Team and residential focus group, comprised of interested citizens throughout the County, have begun their work on updating the residential zoning categories.

Triennial Update to the Carroll County Water and Sewer Master Plan

Carroll County does not have a central regulating authority that provides water and sewer service. However, there are a number of municipal systems and several County-owned community water and/or sewer systems. The Water and Sewer Master Plan encompasses all of Carroll County, including the County's eight incorporated towns and cities. The Maryland Department of the Environment (MDE) has regulatory authority over the systems described in the plan. The Water and Sewer Master Plan is an implementing measure of the Carroll County Master Plan. The plan takes into account the policies and visions of the county and municipalities when deciding the areas that will be served with water and sewer. However, the plan does not guarantee that the County or any municipality will provide services.

The Annotated Code of Maryland requires the County to review and adopt a Water and Sewer Master Plan every three years; the current Master Plan was adopted in 2014. Amendments to the master plan may occur between the Triennial updates; these typically occur twice a year as a spring and/or fall amendment.

The Department of Planning processed and submitted the Triennial Update of the Carroll County Water and Sewer Master Plan, to MDE for review and final approval, in April. This update consists of changes made to the 2014 Master Plan, through the Amendment cycle. The Triennial update includes revisions of all Chapters, including the eight Municipal and one County maintained water and sewer systems.

Carroll County's Water & Sewer Master Plan is broken into four chapters.

Countrywide Planning Context:

This update addresses the general population and geographic characteristics of Carroll County.

Water and Sewer Planning in

General: This update addresses the purpose and goals of water and sewer planning in Carroll County including: water and sewer related policies, severability, and water and sewer amendment procedures. In addition, the organization and management of the public community water and sewer systems is described, detailing the responsibilities of the municipalities and various of County departments involved in oversight and operation of the systems.

Triennial Water Chapter Update:

The Water Supply Facilities Section describes groundwater and surface water conditions and existing and proposed water facilities by service area. For each water facility, there is a description of the current conditions, an analysis of needs, and recommendations for future



system improvements. A section on regional water facilities addresses current and potential reservoir sites designed to meet water needs outside of municipalities. This update also revised the Projected Water Supply Demands and Projected Capacity table (15) and the Water Service Area maps.

Triennial Sewer Chapters

Update: The Sewer Facilities Section describes sewage disposal conditions and restrictions in the county. It also describes the existing and proposed public sewer facilities by service area. For each sewer facility, there is a description of the current conditions, an analysis of needs, and recommendations for future system improvements.

All municipal Planning and Zoning Commissions, and the Carroll County Planning and Zoning Commission certified consistency of their respective water and sewer chapters with their Master and/or Comprehensive plans.

The Board of County

Commissioners conducted a duly advertised public hearing regarding the Triennial Update on February 7, 2019. Following the public hearing and subsequent deliberations by the Board, the Triennial Update to the Water and Sewer Master Plan was adopted, as proposed, on February 21, 2019. This update also revised the Sewer Service Area maps and revised the Projected Sewer Supply Demands and Projected Capacity Table (32).



Census Outreach Activities in Carroll County

Census outreach activities are well underway in Carroll County. On June 10, 2019 Commissioner Wantz announced the County's Complete Count Committee (CCC) for the 2020 Census. The Complete Count Committee is a volunteer committee established by the county to increase awareness and motivate residents to respond to the 2020 Census. CCCs serve as a county's "census ambassador" and play an integral part in ensuring a complete and accurate count of the community. Success of the census depends on community involvement at every level. The U.S. Census Bureau cannot conduct the 2020 Census alone and success cannot be achieved without local involvement from Carroll County's respected leaders.

The county was awarded a \$40,000 state grant to help with marketing and outreach. Efforts in Carroll County began on July 1, 2019 and will continue until the Census count is concluded in June 2020. County outreach efforts will include: part-time contractual staff dedicated to the 2020 Census; internet kiosks with iPads located at town offices, clinics and shelters to reach those without access to technology; volunteer and staff training; advertising, giveaways, materials and staffing for events. Emphasis will be placed on reaching historically hard-to-count areas and populations.

The U.S. Census Bureau conducts a count of every person living in the United States every 10 years, mandated by the <u>U.S.</u> <u>Constitution in Article 1, Section 2</u>. The data collected by the decennial census determines the number of seats Maryland has in the U.S. House of Representatives and is also used to distribute billions in federal funds to its local communities.

The law requires the Census Bureau to keep all information confidential and use it only to produce statistics.

New to this Census is that it will mainly be conducted electronically, so by April 2020, households will receive an invitation to participate in the census. You'll then have three options to respond: online, by phone, or by mail. We'll mark Census Day on April 1, 2020, with events across the country. This is a key date for the 2020 count: When completing the census, you'll note where you are living on April 1.

Planning is proud to be a part of this important effort by supporting the County's CCC and state and federal officials to get the most accurate and complete county as possible. Stayed tuned for our Census related efforts on our website.

Q. What is Sustainable Communities?

A. The Maryland Department of Housing and Community Development's Sustainable Communities Program is a place-based designation offering a comprehensive package of resources that support holistic strategies for community development, revitalization, and sustainability. Sustainable Communities has provided local governments with a framework for promoting environmentally, economically and socially responsible growth and development in existing older communities.

The 2010 Sustainable Communities Act defines Sustainable Community Areas as places where public and private investments and partnerships achieve:

- Development of a healthy local economy;
- Protection and appreciation of historical and cultural resources:
- A mix of land uses:
- Affordable and sustainable housing, and employment options;
- Growth and development practices that protect the environment and conserve air, water and energy resources, encourage walkability and recreational opportunities, and where available, create access to transit.

Q. How can I benefit?

The Sustainable Community designation is a threshold requirement for application to certain state programs. Sustainable Communities have access to the interagency Revitalization Toolbox of financing programs and tax credit incentives.

Q. What's next?

A. Carroll County Planning in conjunction with the Finksburg Planning and Citizens' Council (FPACC) will be launching a Finksburg Sustainable Community brand and website in the coming months...be on the lookout!
