- c. Employment Initiatives for Veterans Update (John Veney) No report.
- 4. <u>Update on Veteran Direct Home and Community Based Services Program Grant</u> (Francine Hahn) Currently four veterans are being served by the grant with one vacancy in the program. They do have the ability to add more but will wait until staff openings are filled.
- 5. <u>Update on Veteran Services Program Grant</u> (Francine Hahn) Currently two are in a hotel with one approved for HUD-VASH and waiting for their voucher and one being assisted by the Lions Club because they are over income for HUD-VASH. Assistance has been provided to a veteran who is a single parent with three children who was furloughed due to COVID-19. Good news is they were called back to work this past Monday.
- 6. <u>Executive Committee</u> (Marc Fisher) The Executive Committee submitted resources to Leslie Wagner for the Veterans portion of the upcoming Aging & Disabilities Resource Guide.
- 7. <u>Census 2020 Update</u> Carroll County's response rate is still the highest in Maryland. Continue to encourage everyone to take the census and currently workers are visiting addresses that have not yet responded. The state reached out to Continuing Care Retirement Communities in the county and reminded them the census is a federal requirement. September 23rd a census enumerator will be joining community partner agencies to count residents at encampments for an accurate non-sheltered survey of the homeless population.
