- viii. Yearly return on investment, based on known awards is approximately \$32,122,000 since inception of the program in October 2013. Yearly Growth Rate from 12/2019 to 12/2020 is 46%.
- ix. Congress recently passed 2021 National Defense Authorization Act which expands Agent Orange, Parkinson's Disease and Hyperthyroidism benefits. The VA has not provided any guidance on this to date.
