- Recently launched the Ready Carroll Preparedness Program.
 - EM expects to hold these month-long community preparedness training programs each spring and fall sessions, in addition to an expert speaker series.
 - Will be putting together information to publish to our webpage.
- We continue to work through the distribution of the physical copies of the EOP to appropriate stakeholders.
 - 35 total copies have already been distributed; about 15 remain.
- Work on both the FEMA RCPGP food & water security and disaster housing plans continues.
- The Extreme Temperature relief center plan will be sent to all appropriate stakeholders in preparation for the upcoming winter season.
- The Evacuation Plan has been in final draft form since 2016. Jacob has been working to get this finalized.
 - Will send this out shortly to all stakeholders for review and approval.
- Have recently resumed work on the Recovery Plan.

- Continues to monitor social media and release appropriate messages to the public via these channels.
