#### 3. Shelter Utilization Review

- Shared HSP excel report
- Will have final FY25 numbers by September
- Overall served less in FY25 than in FY24
- Amy Baker to provide PATH data to add to the utilization update
- PATH
  - i. Have provided outreach to 102 participants
  - ii. Enrolled over 70+
  - iii. Positive outcomes for housing are low
  - iv. No veterans are being served
  - v. Have more male participants than female; age group 39-54 years old
  - vi. Will send numbers for FY25
- Exits to perm housing are declining since 2020
- New NOFO projects for transitional housing

### 4. Upcoming COC NOFO Application Update - Carly and Debby

- Nothing official has come out since our last meeting
- Funding Street Outreach and Transitional housing
- Rapid ReHousing not to be funded as perm housing

### 5. Discussion on new policies for NBN shelter related to capacity restrictions/CE Requirements

- Added in based on vulnerability under new participants
- Define services
- Change of funding source
- Medical accommodation needed if you cannot use a top bunk
- In order to stay in shelter need to enroll in Coordinated entry within 30 days

# 6. Habitat Project – Jenny Graybill

- Habitat for Humanity is building 25-30 houses behind the Health Department
- The entire site has been surveyed
- Geo map of area and plotted out where the encampments are
- Need to have a plan for exit strategy of 13 individuals
- Will have short term and long-term housing options and will allow pets
- Provide a joint letter from the County and the Health Department for the encampments
