#### 5. Shelter Services for December-Joanna Waters

- a. Adult Only served 45 individuals with a 96% utilization rate; 1 individual left to perm housing
- **b.** Family Shelter served 8 families; 12 children; 80% utilization rate; 1 family moved into perm housing
- c. Night by Night served 60 individuals with a 100% utilization rate; 94 different individuals in the month of December
- **d.** Wait list
  - 1. Adult Only 44
  - 2. Family Shelter 3
  - 3. Rapid ReHousing 94
  - 4. Perm Housing 4
- e. On Our Own is now open from 8am-7pm almost every night unless it is slow and would close earlier

#### 6. Domestic Violence - Springboard

- a. Have been at 100% capacity from April-December
- **b.** 2 weeks before Christmas had multiple families move out into perm housing
- c. Capital improvements ongoing; replacing mattresses and painting
