

effects of drought and extreme precipitation events.



The members reviewed the MPRP Environmental Review Documents (ERD) and summarize key environmental impacts covered by the ERD. While the ERD indicated how PSEG intended to address

State requirements related to environmental resources, additional mitigation measures were identified and suggested to be requested of the Maryland Public Service Commission (PSC) to address gaps in State requirements.



## 2025 Environmental Action Awards

The EAC presents awards biennially to individuals and groups for endeavors and projects that result in a positive benefit to the environment and have the potential for long-term community environmental

benefit in each of three categories: Educational Outreach, Positive Practices, and Student Engagement.



The EAC members solicited from local businesses the prizes for

the 2025 [Environmental Action Awards](#) that were presented to the winners.

- Spot-On Engineering Solutions, Inc. – \$1,000 scholarship to Student Engagement Award winner group
- Each of the 3 winner groups received:
  - Sun Nurseries, Inc. – gift basket and gift card to Sun Nurseries
  - JeannieBird Baking Company – \$50 gift basket
  - Local Homestead Products – \$50 gift card
- Rudolph Girls Books – a book for the Educational Outreach winner

The EAC rolled out the public campaign for the Environmental Action Awards in June 2025 to solicit nominations for the awards, including, but not limited to, preparing a flyer, news release, newsletter articles, a distribution list, information on the EAC's webpage, and more. Nominations were accepted through September 22, 2025. The EAC reviewed and evaluated all nominations, and winners were selected by the end of September.

The EAC members presented the awards at a ceremony held as part of the 2025 Carroll EnviroFest on October 25, 2025, at the Robert Moton Center in Westminster.

The document was completed in September 2025.

- ♦ On January 21, 2026, the EAC approved the proposed work plan as a recommendation to the Board.
