- _____ b. Existing topographic information at same interval as the associated plan minimal scale and contour interval).
- _____ c. 100-year floodplains and net tract areas of site based on current zoning at ultimate development.
- _____ d. Current forested and unforested areas, forest stand locations with sampling points and tree lines extending off-site.
- _____ e. State champion trees, trees 75% of the size (diameter) of State, County, or Municipal champion trees and trees 30 inches in diameter or larger.
- _____ f. Steep slopes: 25% and greater and 15% - 25%.
- _____ g. Critical habitats of rare, threatened, or endangered species.
- _____ h. Identification of use III and IIIP waters on plan. Perennial and intermittent streams and stream buffers clearly delineated.
- _____ i. The soils identification must now identify hydric soils, or (soils with a "K" value greater than 0.35 on slopes of 15% or more).
- _____ j. Location of hydric soils.
- _____ k. Non-tidal wetlands.
- _____ l. Existing buildings and structures including: walls, fences, roads, trails, utilities, and easements.
- _____ m. Adjacent land uses and zoning.
- _____ n. Historic structures or other historic resources, including trees.
- _____ o. Site vicinity map. The map shall include the location of the site within a square mile indicating major roads, land uses, and forest cover. (Source: County topographic maps) Maps may be prepared at 1"= 2000'.
- _____ p. Rock outcrops.
- _____ q. Location of dumps and/or other disposal areas.
- _____ r. A 100-foot buffer extending around any existing or proposed community water supply well, as shown on the Carroll County Master plan.
- _____ s. Areas of carbonate rock, initially as identified on the Mineral Resources

Quadrangle Map, Maryland Geologic Survey, further investigations may also be required.

- _____ t. Reservoir watershed number.
- _____ u. Qualified Professional's signature and stamp must be on plan.
- _____ v. Need FEMA Floodplain shown on plan.

- _____ w. Priority forest areas must be shown and identified on the plan as per Chapter 3, 3.0 of the Carroll County Forest Conservation Manual.
