2. Approval of March Meeting Minutes

- a. Tony Roman motions to approve, seconded by Scott Yard
- **b.** minutes approved, no opposition

3. Outreach Update - Judi Nance and Mike Clavin

- a. Taneytown Resource Fair May 22nd with rain date of May 29th
- b. Handed out 60 resource packets at the Union Bridge food distribution
- c. Will have table at carnivals this summer to hand out more resource packets
- **d.** Judi Nance retiring on May 30th

4. Shelter Services - Jennifer Graybill and Yolandie Els

- a. Adult Only served with a 89% utilization rate; 2 individuals move out to permanent housing
- **b.** Family Shelter –67% utilization rate; 5 moved to permanent housing
- **c.** Night by Night served with over 100% utilization rate; 3 out of 33 individuals left to perm housing; 2 moved to adult only shelter; averaging 45 persons per night; seeing high street homeless populations; people living out of their cars; 1 out of 3 individuals is outside Carroll County;
- **d.** Manchester pet pantry providing pet food for homeless individuals that have pets; pets are not allowed into shelter unless they are a service animal

6. Citizen Services Update – Celene Steckel

- a. Housing Danielle Yates
 - 1. ERAP ending June 30th; limited funding is remaining
 - 2. There is no assistance with utilities after ERAP is finished
 - 3. Resources limited for utilities at HSP as well
- **b.** Aging Bobbie Lawrence and Gina Valentine
 - 1. Emergency funds are available through the Kahlert grant on a case-by-case basis
 - 2. Medication take back event had 70 cars in Mt. Airy; May 20th event will be at South Carroll Senior Center

- 3. Farmer's Market voucher application is online, and program begins May 15th
- 4. Veteran Services submitted 6-month report for the Kahlert grant on April 1st; served 38 veterans in case management; 14 of those were homeless; Housed 9 emergency shelter; currently have 3 in emergency housing
- 5. Annual Aging Your Way Expo is September 10th
- 6. Veteran's Celebration on May 5th next year will be our 5-year celebration
- 7. Federal funding hasn't been released; providing normal services across all our program lines
- 8. Federal Funding "skinny budget" low-income home energy assistance program believed to receive a cut in funding; still state assistance for LIHEAP; Block grants from state are flexible CSBG; SamSa funding targeting Harm Reduction is looking to receive a cut in funding
- 9. We are looking to form an Advocacy subcommittee in the Circle of Caring
- 10. Housing choice voucher program proposed to receive a 43% reduction in federal funding and a 2-year cap on funding
- 11. Proposals to have CDBG funding and VASH funding resolved

7. Health Department Update – Amy Baker

- a. Looking at homeless individuals with income and maybe suggesting having roommates to be able to afford housing
- **b.** Harm Reduction program received no cuts in funding for FY26
- **c.** Medication takeback event this Saturday from 2-5pm at Sykesville Police Department The Cow will be there handing out free ice cream
- **d.** Cannabis survey sent out to persons 12+ years old and up
- e. Harm Reduction vending machine to be set up at the Distillery is not yet up and running
- **f.** Naloxone boxes are around the county in 20 locations
- g. Syringe services surveys out to the public to be completed
- **h.** 988 hotline supplies are available rubber ducks swag
- i. CCRE/CLA both had successful conferences and classes
- j. Cathy Baker
 - 1. Have not lost any staff positions
 - 2. Some were level funded
 - 3. Still waiting on funding for pregnant women
 - 4. Will be retiring on June 30th after 40+ years with the State
- **k.** Marie Liddick
 - 1. Most grants are level funding for FY26
- **I.** HSP Grant Application Update submitted HSP application on May 2nd; funds to support homeless prevention, housing stability, street outreach, and Rapid ReHousing; will find out end of May or early June what our award will be

8. Youth Updates – Ed Singer

- **a.** Had YHSC meeting on April 9th Shepherd Staff was supposed to present but was unable to attend; they have a new building project that will be able to better service youth
- **b.** CCYSB reported on programs and having wait lists for connecting youth and family services
- **c.** Working on youth data of homelessness
- d. Chapen Hall virtual conference on gathering youth data through HMIS tomorrow
- e. Milo spoke with the YHSC and shared perspective about youth facing homelessness
- f. Youth Action Board Carly Long
 - 1. Raising awareness through outreach at Resource Fair in Taneytown
 - 2. Have their own space now on the same floor as Citizen Services
 - 3. Will have officer elections in June
 - 4. Updating social media for the YAB with their mission and vision
- g. CCPS Youth Services Kathi Green
 - 1. Seeing stable trends
 - 2. Total youth homeless up and hit 205; largest number in +30 years
 - 3. Do not know the final budget yet for the next school year
 - 4. Receive homeless program audit every year to be held every August
 - 5. Have seen an increase in student absenteeism need to continue to work with parents to get children enrolled and attending school
