 - v. Reviewed 19 veteran cases
 - vi. Have 2 veteran pending VASH vouchers; have 13 HUD VASH vouchers total

- 26 different volunteers from 8 agencies participated
- Unsheltered count got 9 surveys completed; 9-10 additional individuals that we are aware of that were not found
- Sheltered individuals that night was 127; 4 wanted to seek out case management services
- In 2023 PT Count there was 23 unsheltered and 99 sheltered
