- a. Shelter has been at capacity for both July and August
- **b.** Hartley House has been temporarily closed in Frederick due to 100% staff turnover receiving overflow from Frederick

 - 1. Voucher program working with a shortfall team for this calendar year; have paused accepting new vouchers
 - 2. 796 vouchers in Carroll County and also have some move on vouchers
 - 3. Doug Klein new Housing Stability Coordinator started July 31st

7. Youth Updates – Ed Singer

- **a.** Youth Homelessness Subcommittee YSB updates; Liza Guroff is the new Executive Director; Angela Chamar and Kate Swisher are the clinical director roles
- **b.** Connecting Youth program is fully staffed
- **c.** Family Preservation has a 6 week wait time
- d. Enough Act getting community assessment together and presenting to the Commissioners September 18th

- e. YHSC next meeting October 8th
- **f.** Youth Action Board group of youth aged 14-24 with lived experience of homelessness
 - 1. Back to School event in August rock painting activity
 - 2. Youth Homelessness Conference in October
 - 3. Hygiene Drive for the YAB in the month of November
- **g.** CCPS Kathi Green
 - 1. 68 homeless youth identified; number is trending up
 - 2. FY25 finished with 209 youth identified
 - 3. Tutoring and counseling available at the family shelter
 - 4. Don Mongold is returning to mentor unaccompanied youth students; had 3 youth that went to college; connects youth to finances, education and work, and helping to set goals and plan for the future
 - 5. Focus on attendance in the State of Maryland 33% chronic absenteeism across the state; chronic is at least a 10% absenteeism rate during the school year; State goal is to reduce number by half; Carroll County is at 22% chronic absenteeism; messaging campaign to improve school attendance
 - 6. MSOP tier 3 program for students who were chronically absent who stopped attending school due to mental health condition; in home therapy and mentoring with parents or aide; has been successful
 - 7. New program for tier 2 instruction in partnership with Advanced Behavioral Health called the Stars Program -for students who are starting to trend towards poor attendance will provide counseling as well as training and support for parents as they support their children

8. Health Department Update – Amy Baker

- a. Harm Reduction Purple Naloxone boxes are at 20 different locations throughout the county
- **b.** Handed out over 13,000 doses of Naloxone in FY25
- c. Mike Clavin does outreach for homelessness and mental health; has enrolled 70 people in CCHD program
- **d.** Prevention unit has several Coalitions:
 - 1. Suicide Prevention
 - 2. Cannabis
 - 3. Tobacco Cessation
 - 4. Overdose Prevention
- e. Peers Promoting Recovery Month
- f. Lived Expertise Advisory Board still meeting and actively seeking members and working on a charter document
- g. Health Department working on their strategic plan
- h. Medication take back event on October 4th behind the County Maintenance building
- i. Out of Darkness Walk is not happening in Carroll County this year
