- **Caren Jagoda, CCYSB:** Senator Cardin toured CCYSB and participated in great discussions with CCYSB staff and others in the county.
- **Billy Lyve, FYP:** Find Your Purpose’s annual Easter Egg Hunt is April 8<sup>th</sup> at City Park and is free to everyone. Tonight, FYP is taking their youth to Magic Elm Skateland.
- **Maria Buckley, DORS:** DORS is gearing up for their summer youth program for students who have disabilities. Reach out to DORS to refer youth to this summer work experience.

### 2. CCLMB Housekeeping

#### Approval of the February 21, 2023 Meeting Minutes

- The CCLMB February 21, 2023 Meeting Minutes are approved as written.

### 3. FY24 Community Partnership Agreement NOFA Update

After the February 21<sup>st</sup> CCLMB meeting, the Board participated in two votes:

- Which proposals to prioritize and fund in FY24 with the \$25,572 unallocated Community Partnership Agreement (CPA) funds. Ultimately, the Board’s votes resulted in the following:
  - i. 1<sup>st</sup> FY24 CPA Funding Priority: CCYSB’s Suicide Program Expansion at \$17,200
  - ii. 2<sup>nd</sup> FY24 CPA Funding Priority: Boys and Girls Club of Carroll County’s Summer Leadership Program at \$6,000
  - iii. 3<sup>rd</sup> FY24 CPA Funding Priority: Citizen Services’ Youth Housing Stability at the remaining \$2,372
- Whether to use the remaining \$2,372 FY24 unallocated CPA funding to support the Youth Action Board (instead of the youth housing stability proposal).
  - i. Because it was not feasible to fund the youth housing stability proposal with \$2,372, it was proposed that those remaining funds be used to support the Youth Action Board under the CPA Community Support budget.
  - ii. The majority of the Board voted in support of this change.

One change to the FY24 CPA NOFA process is the need to put the Wraparound Family Services program out to bid through the Request for Proposal (RFP) process. This aligns with the County’s procurement process which the other CPA-funded programs underwent.

- The Youth Homelessness Subcommittee continues to meet every month in conjunction with the Connecting Youth Coordinating Council members of the Subcommittee have worked to include youth homelessness and housing instability data from TWOI into the Homeless Management Information System (HMIS). This will facilitate a more comprehensive and synthesized view of youth housing instability which will support our future efforts and future funding and service opportunities.
- The Subcommittee has also arranged to have Melissa Muntz, Executive Director of SHIP of Frederick County, to provide a presentation to the Subcommittee and the Circle of Caring Homelessness Board on April 17<sup>th</sup> from 1:30-3:30. #### 6. 2021-2022 Youth Risk Behavior Survey Results Overview

- Erin Bishop (BGC), Amy Jagoda (CCPS), and Angel Hill (TWOI) stated that the YRBS results align with what they are seeing in their workplaces/program areas.
- Amy Jagoda (CCPS) highlighted the concerning findings of [Carroll County's 2021-2022 YRBS Risk Behaviors and Sexual Identity report](#).
- Maria Buckley (DORS) and Mallory Sutphin (CCYBS) spoke to the importance of sharing this data with not only peers but also the community.
- Several attendees discussed exploring the [Collective Impact](#) model. Gabby Zelaya (LMB) checked the Local Management Board & Local Care Team Technical Assistance Calendar offered by the Governor's Office of Crime Prevention, Youth, and Victim Services and there were no timely offerings of the Collective Impact training. However, Gabby asked the GOCPYVS to continue offering this training in FY24.
- Several attendees discussed utilizing a map of services to better identify what is available. Mallory Sutphin (CCYSB) shared that CCYSB has a comprehensive resource list which might be a good base.
