### 2023 Work Plan Progress

#### Public Outreach – 2023 Environmental Stewardship Booklet Update

The <u>Environmental</u> Stewardship booklet.

updated every other year beginning in 2015, is intended to showcase the great work that Carroll County is doing to demonstrate good environmental stewardship. The booklet was updated this year to reflect current information (as of end of FY 2021).



Several new items were added to the booklet this year.

- Renewable Energy (expanded from "Solar")
- Awards & Recognition
- Social Media & Environmental Symposium (under Public Outreach)

The booklet is available on the EAC's webpage and was distributed via hardcopies and/or email link to the community. Hardcopies were also provided to the delegation as a reference resource.

#### Public Outreach – Preventing, Managing, & Eradicating Invasive Plants and Noxious Weeds in Carroll County

Invasive plants and noxious weeds cause a profound effect on native species, alter habitats, and result in significant economic impacts to agriculture, recreational opportunities, and property.



At the request of the Board of County Commissioners, the EAC developed a public

outreach piece defining invasive plants and noxious weeds. The publication described their negative impacts, offered additional resources for identifying and controlling these plants, and summarized State laws related to noxious weeds and invasive plants. In addition to sharing basic steps for homeowners to prevent, manage, and/or eradicate these plants, several invasive and noxious plants commonly found in Carroll County are highlighted.

#### 2023 Environmental Action Awards

The EAC presents awards biennially to individuals and groups for endeavors and projects that result in a positive benefit to the environment and have the potential for long-term community environmental benefit in each of three



categories: Educational Outreach, Positive Practices, and Student Engagement.

The EAC members solicited from local businesses the prizes for the 2023 Environmental Action Awards that were presented to the winners.

- Spot-On Engineering Solutions, Inc. \$1,000 scholarship to Student Engagement Award winner
- Atlantic Blue Water Services \$500 scholarship to the Student Engagement Award runner up
- Sun Nurseries, Inc. \$275 gift card to Sun Nurseries and a gift basket to Positive Practices Award winner + a \$75 gift card and a gift basket to the Educational Outreach Award winner
- JeannieBird Baking Company \$50 gift basket to each of the 3 winners

The EAC rolled out the public campaign for the Environmental Action Awards in March 2023 to solicit nominations for the awards, including, but not limited to, preparing a flyer, news release, newsletter articles, a distribution list, information on the EAC's webpage, and more. Nominations were accepted through September 30, 2023. The EAC reviewed and evaluated all nominations, and winners were selected in October.

This year, the EAC members presented the awards at a ceremony held as part of the 2023 Environmental Symposium on October 28, 2023, at the Carroll County Agriculture Center. **COMPLETED** 

#### Public Outreach – Residential Graywater Use in **Carroll County**

Graywater is untreated water collected from a clothing washing machine or a bathroom sink, tub, or shower. While not drinkable, it is suitable, and even beneficial, for irrigating certain areas of the yard, which also helps to conserve water usage. The 2018 Maryland General Assembly passed legislation (Senate Bill 496/Chapter 705) to allow residential graywater for certain uses. The legislation requires Maryland Department of the Environment (MDE) to develop regulations to implement the bill's provisions.

Per the 2018 Work Plan and continued to each of the work plans since that time, the EAC will research homeowner graywater usage and prepare a public outreach piece to provide Carroll's residents with basic information regarding graywater, its residential uses, and its benefits. The materials will be made available in hardcopy and online.

The EAC is currently waiting on regulations to be released by MDE. These regulations need to be available before the EAC can inform the public of the process(es) and requirements associated with use of residential graywater in Carroll County. **ON HOLD** 

#### 2024 Work Plan

The EAC developed a work plan for proposed projects to be completed during the 2024 calendar year. On January 17, 2024, the EAC approved proposing these projects to the Board. The work plan will be finalized pending discussion with the Board, any additional

#### Solid Waste Committee Service on Solid Waste Advisory Council (SWAC):

The SWAC, which is facilitated by the Department of Public Works (DPW) staff, serves in an advisory capacity to the DPW regarding implementation of recommendations from the former Solid Waste Work Group's report, input on potential capital projects and future directions, as well as public outreach efforts. An EAC member typically serves on the SWAC as a liaison between the two groups to allow for additional collaboration and input to the SWAC. The SWAC has been inactive. An EAC liaison will be chosen if the SWAC becomes active again. **ONGOING – NO ACTIVITY IN 2023**

  - In fall 2023, the EAC drafted a proposed 2024 Work Plan in preparation for the annual joint meeting with the Board, which is typically held in late January.
  - On January 17, 2024, the EAC approved the proposed work plan as a recommendation to the Board.


