# **Capital Project Update:**

Update provided by Will Brozy-

- Bear Branch Pavilion construction is underway. Expected to be completed within 3 weeks.
- Piney Run Paving project will have to rebid due to coming in over budget. Scaled down the project to fit within the budget.
- Piney Run Tennis Court Conversion and Basketball court resurface this project is still included in the bid with the paving project.
- Freedom Challenge Course will be complete after BBNC Pavilion. Completion expected end of October/early November.
- Cape Horn Lights Phase II complete and operational.

Mr. Gerkin - How many baseball fields for dirt?

Mr. Roelke -2 fields. Try not to get more than what we need.

Mr. Gerkin - you can get 2 fields out of the new fields?

Frank – Yes, 2 fields and more.

## Freedom Rec Council -

1st Request - Rehab Shed at Old Liberty Road \$7,800 - Representative Sue Chaney

Mr. Gerkin – Is the shed for sports equipment? Ms. Chaney -Yes.

Mr. Gerkin – how many fields?

Ms. Chaney - 1 field.

2<sup>nd</sup> Request – Old Liberty Road Park Ball Dirt \$ 2,479 – Representative Lori Doyle 3<sup>rd</sup> Request – Infield Fence at Obrecht Road Fields \$ 15,699 – Representative Lori Doyle

Mr. Johnstone – can't use the field for games now? Ms. Doyle – Not as much, due to the foul balls hitting vehicle. Ms. Karr-Kratz – Did you receive 3 quotes? Ms. Doyle – yes.

# North Carroll Rec Council – Representative Derek Ludlow

Repair field lighting at North Carroll Middle School \$7,144 (Priority 2)

Mr. Woodley – How dangerous is the field with out the lights? Mr. Ludlow - Danger is not an issue. Still able to use the fields. Would be nice to use the field with them lit.

Mr. Gerkin – LED option?

Mr. Ludlow - Will has the cost for the LED option. It is out of the Self-Help range. Would be a full conversation. Wouldn't want to put LED bulb/fixtures in when the poles need to be replaced.

Ms. Karr-Kratz – How long to the bulbs last?

Mr. Ludlow – Do not have the answer for that. They have been replaced as needed. Turning lights on 30hrs a season. Lacrosse is at Cape Horn.

Ms. Karr-Kratz - The schools don't get involved since it evening hours?

Mr. Ludlow – BOE is looking into who should be taking care of fixtures on their grounds.

Mr. Kiler – Spoke about BOE and R&P agreement regarding who is responsible for maintenance of fields.

### West Carroll Rec Council - Representative Nikki Bayer

1st Request – FSK Field Hockey goals at Bark Hill \$3,168

Mr. Gerkin – 2 goals, correct?

Ms. Bayer – correct, we would put them together and put nets on. Baugher family have offered to help.

### Westminster Area Rec Council -

1<sup>st</sup> Request –Winters Mill HS/Grindstone wrestling mat \$11,135 (Priority 2) - No Show

## Winfield Rec Council -

1st Request – Winfield Park Batting Cage \$13,563 – Representative Jackie Brown

Ms. Karr-Kratz – This would go on Salem Bottom Rd? Ms. Brown – Yes, that is correct.

2<sup>nd</sup> Request – Mayeski Temp Outfield Fencing \$7,798 – Representative Larry Holston

Mr. Holston - Need to have the fencing to have games at these fields. Currently put them up and down right now.

Ms. Karr-Kratz – Storage on site? Mr. Holston – Yes, we do.

Public Comment (Dawn Prosser) – what happens with the remaining balance? Mr. Gerkin – would do another request in the spring. Mr. Brozy – rolls over to the next funding cycle.

Discussion regarding any issues with the quotes that were received. Only issue was Westminster wrestling mats and they did not show up.

Discussion on being present at the meetings for the Rec Council to receive Self-Help funding. Ms. Carroll noted that it is a requirement that someone be present from the Rec Council to receive funding and this was voted on by the board. Discussion regarding West Carroll Field Hockey Goals – only requested 2 goals, instead of 4. They also are doing a portion of the labor but did not include volunteer hours. Additional discussion on 75/25 allocation and volunteer contribution.

**MOTION** - Mr. Gerkin motioned to approve the self-help projects removing the Westminster Area Rec Council Wrestling Mats. Mr. Duffy second. Unanimous vote.

Discussion regarding spring allocation for projects. Ms. Carroll noted that the spring is the only time the PTA group can apply for funding.

Public Comment (Dawn Prosser) – New to rec council, not going to be able to sustain the teams and programs. The lights will be a capital project. Running into issues with finding the current bulbs that are required.

Mr. Ferguson – Yes, will have trouble finding these bulbs.

Public Comment (Dawn Prosser) – BOE and Rec and Parks will need to learn to work together. Lights at Kate Wagner. Stop blaming each other and figure it out together. Its going to come to a head eventually. We need lights.

Ms. Brozy – A lot of infrastructure that is failing. POS was drastically reduced.

Public Comment (Dawn Prosser) – Look at the bigger picture and how it is affecting the kids. Mr. Gerkin – We get it. It is a serious problem.

### **Other Business:**

Director Hicks -

Megan Vaugh – resigned.

Open position that needs to be filled

We have received 23 applications. Required to diversify throughout the county. If there are no issues, I will forward over to the Commissioners.

Only in first term so you can go for a second term. Don and David plan to stay. Anita expires end of 2025. Austin end of April 2025.

Bylaws are not clear for the person that would fill in for Megan's position. Trying to determine if they would they be eligible for two more terms after finishing Megan's term.

Additional discussion on Self-Help regarding when/how the information is sent out to the Rec Councils. Plenty of information provided at Rec Council meetings and email notifications to make all programs aware of the funding availability.

Additional discussion from Ms. Karr-Kratz:

Ms. Karr-Kratz – would like to start a wellness program. CPR training involved for the volunteer. Is that something we can provide for them?

Ms. Carroll - Heather is from Charles Carroll. We have offered but not many people take advantage. We would not have funding in our budget to pay. Can certainly help them find somewhere to get training.

Mr. Woodley – we have purchased AEDS through our programs.
