	<ul style="list-style-type: none"><li>• Received many compliments from the Aging Your Way Expo and from fellow commissioners.</li><li>• Sue Krebs has begun serving as the new commissioner for District 5.</li><li>• Commissioner Vigliotti asked which areas still need representation on the commission. Gina noted we need a family representative for developmental disabilities. Possible outreach includes ARC, Target, and Flying Colors to see if they have a representative who might be interested. Additional openings include: Mt. Airy, veterans, and an individual with a developmental disability/SIP. <i>Note:</i> At least 50% of members must be 60 or older. Gina recommended reviewing the bylaws for clarification and considering any changes that may be needed.</li><li>• Vigliotti prefers the virtual aspect for future COAD meetings to accommodate everyone's schedules.</li></ul>
<b>Bureau of Aging &amp; Disabilities</b>	<p><u>BOAD Update – Gina Valentine</u></p> <ul style="list-style-type: none"><li>• Gina introduced the new Event and Project Specialist, Amanda Coshun.</li><li>• The County has decided to change the name from “Bureau” to Division of Aging and Disabilities; this may also result in some job title changes.</li><li>• Expo Updates: Projected attendance was approximately 1,500. The event included 11 different screenings, as well as acupuncture and reiki therapy. Screening results were reviewed. A wrap-up Expo meeting is scheduled for October 28th.</li><li>• OAAPS: Work will begin once instructions are received from the MDa.</li><li>• Older Americans Act Final Rule: Passed and must be in compliance by October 1st. A list of all relationships must be compiled and sent to MDa by September 30th to ensure there are no conflicts of interest. Contract with Legal Aid also needs to be renewed.</li><li>• Federal Funding: MDa has not yet received notification of grant awards. Business will continue as usual until funding updates are received.</li><li>• SOAR (Supporting Older Adults with Resources): The Senior Care Program will remain, but the Senior Assisted Living Subsidy (SALS) Program will be phased out. A new structure for SOAR will be introduced.</li><li>• Proposed Legislation: MDa is considering submitting legislation that would allow nonprofits to apply for certain state programs. Concerns were raised about possible duplication of services. More information will follow.</li></ul>

	<p>Amy Baker</p> <ul style="list-style-type: none"><li>• September is Recovery and Suicide Prevention Awareness Month.</li><li>• Document shredding event: October 4<sup>th</sup> 8:00 AM – 12:00 PM next to the County Maintenance Building. Includes medication disposal and hazardous waste collection. For residential use only (no commercial use).</li><li>• Peer support is available at the Health Department for referrals. Open to individuals age 18+ who are seeking recovery.</li><li>• The team is developing a strategic plan. Numerous focus groups and surveys have been conducted; however, there have been challenges organizing Hispanic/Latino focus groups. Key issues identified include transportation, housing, behavioral health, and access to care. A consulting group is finalizing the report, with release expected in October.</li><li>• Cheri Ebaugh noted that, according to the CDC, in 2023 the highest suicide rates were among older adults, particularly those ages 75–84 and 85+.</li></ul>
